Instructions for Completing Affidavit of Support for International Students at Lehigh Carbon Community College

This form (one form per sponsor) is to be completed by the person who will be providing financial or other support to a student at the college. **You must complete the form thoroughly and in English.** (If there is more than one sponsor, each sponsor must complete one affidavit) The sponsor(s) must complete ALL sections on the form. Any **section left unanswered could result in refusal of the I-20.**

THE FOLLOWING INFORMATION MUST BE ATTACHED TO THE AFFIDAVIT OF SUPPORT:

SUPPORTING EVIDENCE- The sponsor must submit evidence of the ability to financially support the student for the duration of studies at LCCC, including tuition, books, living expenses, etc... This information must be submitted **in English and all figures must be in US dollars.** Please consult the Information Packet for current tuition and other estimated expenses. The following documents are required:

1. Current Bank statement or a letter from an **officer of the bank or other financial institution** (on their stationary) in which you have deposits giving the following details, amount should cover at least one year's worth of tuition and living expenses:
 - a. **Must be dated within 3 months**
 - b. **Present balance (in US dollars) should at least \$37,000**
2. Salary Statement-pay stubs, taxes returns:
 - a. **Salary paid (In US dollars)-indicate whether monthly or yearly**
 - b. **If self-employed provide a copy of last income tax return filed**
