



Lehigh Carbon Community College and Cedar Crest College

DUAL ADMISSIONS INTENT FORM

Lehigh Carbon Community College (“Lehigh Carbon”) and Cedar Crest College (“Cedar Crest”) enter into this Dual Admissions Agreement (“Agreement”) for students pursuing an Associate in Arts (AA) or an Associate in Science (AS) degree at Lehigh Carbon to be admitted as a junior to Cedar Crest. Student will complete a “Dual Admissions Intent” form and satisfy all other Cedar Crest College transfer eligibility requirements. By satisfying the conditions of the Dual Admissions Agreement, Cedar Crest College will do the following:

1. Waive the \$35 admissions application fee.
2. Award academic scholarships to Lehigh Carbon students who graduate with a 3.0 GPA or higher.
3. Provide the Lehigh Carbon student with the opportunity to meet with a Cedar Crest representative for assistance with transferring to Cedar Crest (prior to graduating from Lehigh Carbon).

The signing of this agreement indicates the students’ understanding of the following conditions:

1. Student shall have an earned high school diploma or its equivalent prior to signing a “Dual Admission Intent” form.
2. Student shall complete a “Dual Admission Intent” form (available on the Lehigh Carbon website).
3. Student shall complete no more than 30 credits of post-secondary academic course work prior to enrolling in the Cedar Crest-Lehigh Carbon Dual Admission Program.
4. Student shall maintain a 2.00 cumulative grade point average for all post-secondary academic course work for general acceptance into Cedar Crest College. *Please note certain majors have minimum GPA requirements. Please consult with your advisor.*
5. Student shall graduate from Lehigh Carbon with an Associate of Arts or Associate of Science degree.
6. Student shall enroll at Cedar Crest College within one year of graduation from Lehigh Carbon.
7. Student will not attend another post-secondary institution after graduating from Lehigh Carbon and before enrolling at Cedar Crest College.
8. Student shall complete all admissions requirements within appropriate deadlines as determined by and to the satisfaction of Cedar Crest.
9. Student will receive a special Cedar Crest identification sticker to be affixed to the student’s Lehigh Carbon identification card, which shall entitle the student to admittance to selected campus events free of charge or at reduced student rate, including theatre productions, concerts, recitals, Student Government and Athletic events.

NOTE: Lehigh Carbon students enrolled in the Dual Admission Program and participating in or attending activities, classes, and events at Cedar Crest will be subject to the rules and regulations governing all Cedar Crest students while on College property.

10. Student shall complete all admissions requirements within appropriate deadlines as determined by and, to the satisfaction of, Cedar Crest. Students must confirm their intention to matriculate at Cedar Crest by May 1st for the fall semester, and by December 1st for the spring semester. The School of Adult and Graduate Education (SAGE) requires no deadlines for intent to matriculate as this program is a rolling admissions format.

11. Male students are not eligible for the day admissions programs with the exception of Nursing and Nuclear Medicine Technology. *See Appendix A for a list of programs.*

You, the student, may void this agreement at any time with written notification to the Office of Advising and Transfer at Lehigh Carbon.

Male students are not eligible for the day admissions programs with the exceptions of Nursing and Nuclear Medicine Technology. ***Male students will make application to the School of Adult and Graduate Education (SAGE). Female students graduated from high school four (4) or more years will make application to the School of Adult and Graduate Education (SAGE).***
