**Guaranteed Dual Admission Intent Form**

The Guaranteed Dual Admission agreement between Lehigh Carbon Community College (LCCC) and Delaware Valley University (DVU) is designed to allow students who complete their Associate degree in Biology, Business Administration, Chemistry, Communication, Criminal Justice, Mathematics/Natural Science-Life Science/Biology/Chemistry/Environmental Science/Physics, Hotel Resort Management, General Studies/Liberal Arts, Education, Psychology and Social Work at LCCC to transfer into corresponding Bachelor's degree program at DVU as listed in the Guaranteed Dual Admission Agreement.

By satisfying the conditions of this agreement (as outlined in the Guaranteed Dual Admission Agreement), the student will have the following advantages:

- DVU's \$50 Application Fee will be waived
- LCCC students will have the opportunity to meet with a DVU representative for assistance with transferring to DVU (prior to graduating from LCCC)
- LCCC students, who have a 2.50 GPA or higher, will receive an academic scholarship providing they enroll for 12 or more credits per semester at DVU. The higher the GPA, the higher the scholarship offered to the student. See the scholarship information on DVU's website (<http://delval.edu/transfers>) for a listing of the various awards.
